

## NOTICE TO RECIPIENTS

THE TRAFFIC HAS BECOME A SERIOUS PROBLEM AND THE PASCO COUNTY SHERIFF'S OFFICE HAS ASKED US TO DO SOMETHING TO CONTROL THE BACKING UP OF TRAFFIC ON SR54. THERE IS NO TURN LANE ON 54; THEREFORE, STOPPING OF CARS CREATES A SERIOUS PROBLEM AND COULD CASE A SERIOUS ACCIDENT. IF WE DON'T DO SOMETHING THEY WILL HAVE TO POSSIBLY CLOSE THE PANTRY. PLEASE UNDERSTAND AND COOPERATE WITH THIS LAST EFFORT IN CONTROLLING THE FLOW INTO THE FOOD PANTRY SO WE CAN CONTINUE TO HELP YOU ALL.

IN AN ATTEMPT TO SOLVE THE TRAFFIC PROBLEMS ALONG STATE ROAD 54 CREATED BY THE INCREASE OF RECIPIENTS COMING TO OUR FOOD PANTRY WE HAVE FOUND IT NECESSARY TO IMPLEMENT THE FOLLOWING RULES EFFECTIVE WEDNESDAY, FEBRUARY 7, 2024.

1. ON WEDNESDAY, FEBRUARY 7, WE WILL BEGIN ISSUING TIMES FOR ARRIVAL AT THE FOOD PANTRY. THESE WILL BE PERMANENT ARRIVAL TIMES ISSUED TO BE HUNG ON YOUR REARVIEW MIRROR. IT IS IMPORTANT TO MAKE SURE THAT THESE TIME TAGS ARE LEFT IN YOUR VEHICLE AND IN PLACE ON REARVIEW MIRROR UPON ENTRY ON THE PROPERTY. THE ARRIVAL TIMES WILL BEGIN AT 8AM AND BE SPACED EVERY 15 MINUTES THEREAFTER. THESE TIMES WILL BE REGISTERED ON THE RECIPIENTS RECORDS.
2. THESE TIMES WILL BE STRICTLY ENFORCED. ANYONE ARRIVING PRIOR TO THEIR DESIGNATED ARRIVAL TIME WILL BE ASKED TO LEAVE AND RETURN AT THEIR DESIGNATED TIME.
3. NO ONE SHALL BE PERMITTED TO PARK IN THE OFFICE COMPLEX ADJACENT TO THE CHURCH PROPERTY. IF DONE, YOU WILL BE ASKED TO LEAVE.
